

LISTEN TO THE FLOWER, MAKE THE DIFFERENCE!

- Do not open the windows when the heating in the common areas is on.
- Turn off the lights in the common areas when not needed and, in particular, when you go out.
- To Reduce your water consumption:
 - Turn off the taps when brushing your teeth;
 - Do not let the water run in the shower needlessly
- Promptly inform our staff if you notice any water leaks.
- Use the correct amount of washing powder in the washing machine depending on the hardness of the water indicated in the laundries.
- Use the bins located in the common areas only when absolutely necessary (small trash such empty bathing bottles); sanitary napkins, and paper trash must not be thrown into the WC; any hazardous chemical substances and/or fats or grease must be deposited in the depot outside the campsite; any waste or hazardous substance or any object that may damage or block the normal functioning of the pipe-systems, must not be thrown into the pipes.
- Please recycle the wastes by taking them to the depot located outside the campsite (parking area entrance), where you will find:
 - The yellow recycling bin for paper and cardboard to be used also for newspapers, notebooks, old books, magazines, food boxes,
 - The green recycling bin for glass,
 - The white recycling bin for plastic,
 - Specific black trash cans for recycling of polystyrene, metal tins, aluminium cans, used cooking oil, hazardous waste (sprays, used batteries, automobile batteries, refrigeration devices...),
 - Specific container for medicinal wastes or expired medicines (which may also be handed back directly to the local pharmacy in Pellizzano).
- Al fine di ridurre l'uso di veicoli a motore, sono a Tua disposizione biciclette per brevi spostamenti locali, di cui puoi fare apposita richiesta alla Reception; è disponibile, inoltre, un carrello per il trasporto della spesa effettuata presso il nostro mini-market.

- In order to reduce the use of motor vehicles; you may hire bicycles at the reception desk for short trips in the area. In addition a trolley is available for carrying items purchased at our mini-market.
- You are kindly requested to wash your car or motorcycle at the petrol station located in Malè only. Washing your own car or motorcycle at the campsite can be authorized by Management in special cases and will be allowed in the Camper-service area only.
- Please respect the quiet times from 1:00 p.m. to 3:00 p.m. and from 11:00 p.m. to 7:00 a.m.; during these hours it is forbidden to drive around the campsite, to assemble or dismantle camping equipment, make any noise and listen to the radio or watch TV at high volume.
- Drive around the campsite at walking pace.
- It is absolutely forbidden to light fires in the campsite and the surrounding areas. Metal grills are allowed provided they are raised above the ground and far from vegetation. Before using these grills, verify the location of the closest fire extinguisher.
- Italian law strictly forbids smoking in all common areas; do not smoke inside the buildings and use the outdoor areas.
- We also remind you that both at the Reception Desk and on the Environment Notice Board you will find all the necessary information for using the local public transport; we invite you to use it for travelling in the local area.
- On our notice board you will also find information regarding the local flora and fauna, the countryside, the specific bio-diversities, the parks, nature conservation measures and policies adopted on the premises.
- Our staff periodically organizes evening meetings aimed at the discovery of the local flora.

In addition, in collaboration with the Stelvio Natural Park, guided visits and learning activities are held; for any information and program please contact our staff directly.

We will be glad to receive any suggestions of yours to help us further improving eco-sustainable tourism.

QUESTIONNAIRE ABOUT THE ENVIRONMENT
